to revive and amend the law relating to the Karachi Development Authority.

WHEREAS in order to give impetus and Preamble. encourage the housing industry and provide shelter to the people of the Province, it is expedient to revive and amend the law relating to the Karachi Development Authority.

It is hereby enacted as follows:-

- 1. (1) This Act may be called the Karachi Development Short title and Authority (Revival and Amending), Act, 2016. commencement.
 - (2) It shall come into force at once.
- The Karachi Development Authority Order, 1957, Revival of Order shall stand revived on and from 1st day of July, 2002, V of 1957. as if it had never been repealed and on revival, the said Order shall stand amended to the extent and in the manner hereinafter appearing.

- 3. In the said Order, in Article 5 -
 - (i) for clause (1), the following shall substituted:-

Amendment of Article 5 of be Order V of 1957.

- "(1) Constitution of the Governing Body.- The Governing Body shall consist of -
- (a) Minister, Local Government, Chairman Housing Town Planning Department
- Members of the Member (b) Two Provincial Assembly to be nominated by Government
- (c) Secretary, Local Government Member and Housing Town Planning Department
- (d) Commissioner, Karachi

(e) Director General, Karachi Member/

Development Authority Secretary (f) Member Technical Karachi Member

Saving.

4. All orders made, proceedings taken, appointments, made, acts done by any authority, or by any person, which were made, taken or done, or purported to have been made, taken or done between the first day of July, two thousand two, and the date on which this Act comes into force (both days inclusive), shall, notwithstanding any judgment of any court, be deemed to be and always to have been validly made, taken or done under the Karachi Development Authority Order, 1957 and shall not be called in question in any court or forum on any ground whatsoever.

STATEMENT OF OBJECTS AND REASONS

In order to encourage the housing industry and provide shelter to the general public, it is expedient to revive and amend the Karachi Development Authority Order,1957 by this enactment.

The Bill seeks to achieve the above object.
