# A BILL further to amend the Khyber Pakhtunkhwa Local Government Act, 2013.

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), for the purpose hereinafter appearing;

It is hereby enacted as follows:

- 1. Short title and commencement.—(1) This Act may be called the Khyber Pakhtunkhwa Local Government (Sixth Amendment) Act, 2015.
  - (2) It shall come into force at once.
- 2. Amendment of section 84 of the Khyber Pakhtunkhwa Act No. XXVIII 2013.—In the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), the existing section 84 shall be re-numbered as sub-section (1) of section 84 and after sub-section (1), as so numbered, the following new sub-section shall be added, namely:
  - "(2) Subject to this Act, in case a Nazim, District Government or Tehsil or Town Nazim fails to approve the budget of a District Council or the Tehsil or Town Council, as the case may be, not less than twenty per cent of the members of the concerned Council shall place requisition before the Council asking the concerned Nazim to seek fresh vote of confidence from the Council concerned and if, he fails to get the vote of confidence, then the Nazim shall cease to hold the office."

#### STATEMENT OF OBJECTS AND REASONS

It is desirable to amend the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013). Hence, this Bill.

  - "(2) Subject to this Act, in case a Nazim and Naib Nazim, District Government or Tehsil or Town Nazim fails to approve the budget of a District Council or the Tehsil or Town Council, as the case may be, not less than twenty percent of the members of the concerned Council shall place requisition before the Council asking the concerned Nazim and Naib Nazim to seek fresh vote of confidence from the Council concerned and if, they fail to get the vote of confidence, then the Nazim and Naib Nazim shall cease to hold the Office."
- 2. Mr. Iftikhar Ali Mashwani, Mr. Shah Hussain Khan, Sardar Muhammad Idrees and Mr. Zareen Gul, MsPA to move that in the proposed sub-section (2) as referred in clause 2, after the word "Nazim" wherever occurring in the section, the words " or Naib Nazim" may be inserted.
